Small Grants Fund: approval of project proposals for 2001

<u>Action requested</u>: The Standing Committee is requested to receive the report of the Subgroup on Finance relating to this item and make decisions as appropriate.

Income and funds available for allocation

- 1. In an effort to raise funds for the 2001 round of the Ramsar Small Grants Fund (SGF), the Bureau wrote in July 2001 to all Ramsar Contracting Parties that are donor countries (as it did in 1998, 1999 and 2000) soliciting their support. The contributions and pledges received up to 15 September 2001 are shown in Annex 1, which indicates that the funds available for allocation to SGF projects in 2001 amounts to SFR 324,171.
- 2. In addition, WWF International have confirmed that they will fund the 2001 proposal from Algeria (SGF/01/DZA/1) through the support provided to Ramsar Contracting Parties from their Living Waters Campaign, and are also considering funding for the 2001 proposal from Mongolia (SGF/01/MNG/1). Furthermore, Wetlands International has pledged to fund three 2001 proposals, from Belarus (SGF/01/BLR/1), Bulgaria (SGF/01/BLG/1), and the Slovak Republic (SGF/01/SVK/1), through its Netherlands DGIS framework agreement supporting wetlands wise use and conservation. At the Standing Committee meeting, an update will be given on this matter.

Project allocations

- 3. Following the established procedure, the Bureau reviews and ranks the SGF projects using the approved form for SFG project evaluations. This review is then communicated to the Subgroup on Finance, which meets on the day preceding the Standing Committee meeting to consider the Bureau's advice. In accordance with Decision SC20.31 of the 20th Meeting of the Standing Committee, the Bureau's recommendations have been provided to the Regional Representatives in the Standing Committee from regions from which project proposals have been received, for their consideration and comment. This was done on 14 September 2001 with a deadline for comment by 30 September 2001. No comments have been received.
- 4. For the 2001 SGF cycle, 49 proposals (10 from Africa, nine from Asia, 19 from Europe, 10 from the Neotropics, and one from Oceania) were considered as administratively complete, including the endorsement of the Ramsar Administrative Authority in each country, and underwent review by the Bureau using the approved SGF Project Proposal Assessment Form. The form has been designed to provide both structure and objectivity

- to the way that the Bureau undertakes its assessment and preparation of recommendations for funding.
- 5. Through Standing Committee Decision SC25-24 a modification was introduced for the 2001 SGF cycle so as to include a score in the Bureau assessment of eligible projects for the technical quality of the project proposal. This additional element of assessment has proved a helpful addition to the assessment process, and the scores and ranking provided in Annex 2 fully incorporate this revised assessment procedure.
- 6. It should be noted that in order to seek equity of allocations among the Ramsar regions, the Bureau has prepared its advice on a region by region basis and used this to formulate its overall recommendation by placing the top projects from each region into the first priority (Category A1) for immediate funding.
- 7. On the basis of the Bureau's assessment, as shown in list of projects by region in Annex 2, the projects have been divided into five categories A1 and A2; B; C; and D as follows:
 - (A1) Projects that are technically sound and of highest priority for funding with the funds on hand. This includes eight projects (two projects each from Africa, Europe, and the Neotropics, and one each from Asia and Oceania) with a total project cost of SFR 297,780.
 - (A2) Projects recommended for funding (in priority order based on the assessment score received by each project) if additional resources should become available for the 2001 SGF cycle. A further SFR 518,010 is required to fully fund all 13 of the A2 projects.
 - (B) Projects that are technically sound and are of medium priority for funding from the SGF.
 - (C) Projects that are technically sound but of lower priority for funding from the SGF.
 - (D) Projects that, on the basis of the information provided, are not considered technically sound or feasible.
- 8. The Subgroup on Finance may wish to note that one country (Guatemala) has one project proposal rated A1 and another rated A2, and two countries (Colombia and Congo) each have two project proposals rated A2. The Subgroup may wish to consider whether to recommend that, should additional funds become available, only one project per Contracting Party should be funded from the A1/A2 list, so as to ensure maximum spread of benefit to the Parties from the allocation of available funding.
- 9. Concerning pending reports from previous SGF funded projects, the Bureau has been reminding the relevant Contracting Parties of this obligation at regular intervals. The project assessment made by the Bureau on a region by region basis (Annex 2) shows those Parties for which reports remain outstanding as of 14 September 2001. One of the recommended A1 rated projects (Papua New Guinea) is from a country with an outstanding report from a previous project (with its final report due in October 2001). One country (Romania) with a project in the A2 rated list has previous SGF project reports outstanding.
